Thumb Roast Coffee, L.L.C. PRIVACY POLICY

This Privacy Policy covers Thumb Roast Coffee, L.L.C. Collection and Use of Personal Information

First, we collect anonymous, aggregate information from all Users of our website. Such information is generally not linked to any personally identifiable information and is primarily used in the aggregate to generate statistical reports about the use of our site.
